

CHERRY BLOSSOM RUN BFSFCU'S RAFFLE 2024

1. **ELIGIBILITY.** The drawing is open to current members of Bank-Fund Staff Federal Credit Union® (BFSFCU®) in good standing (as determined by Sponsor in its sole discretion) who are eighteen (18) years of age or older at the time of entry. You are NOT eligible to enter the Contest if you are (a) a Credit Union employee or independent contractor of the credit union (b) a promotional supplier or employee of a promotional supplier; or (c) a judge involved in the Contest, including anyone who participates in selecting the Winners.
